An Act to Amend the Property Transfer Tax Act

[21st April, 1986

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Property Transfer Tax (Amendment) Act, 1986, and shall be read as one with the Property Transfer Tax Act, 1984, hereinafter referred to as the principal Act.

Short title and commencement.
Act No. 12 of 1984

(2) This Act shall be deemed to have come into operation on the 1st April, 1986.

2. Subsection (2) of section *four* of the principal Act is amended by the deletion of "two and one-half per centum" and the substitution therefor of "five per centum".
