# An Act to amend the National Agricultural Marketing Act, 1989

[11th May, 1990

ENACTED by the Parliament of Zambia.

1. This Act may be cited as the National Agricultural Marketing (Amendment) Act, 1990, and shall be read as one with National Agricultural Marketing Act, 1989, in this Act referred to as the principal Act.

- 2. Section two of the principal Act is amended—
  - (a) in the definition of "agricultural requisite" by the insertion after the words "means any " of "fertilizer,";
  - (b) by the deletion of the definition of Company.
- 3. Section three of the principal Act is amended-
  - (a) by the deletion of paragraph (g);

(b) by the re-numbering of paragraph (h) as paragraph (g).

4. The principal Act is amended by the repeal of section five.

5. Section six of the principal Act is amended by the deletion of subsection (2) and by the re-numbering of subsection (1) as section six.

6. Section seven of the principal Act is amended by the Adeletion of the words "or the Company" wherever they appear.

7. Section eight of the principal Act is amended by the deletion of the words " and the Company ".

8. Section twenty-two of the principal Act is amended in paragraph (f) of subsection (1) by the deletion of the words "or to the Company".
