An Act to amend the Companies Act

[30th April, 1993

ENACTED by the Parliament of Zambia.

1. (1) This Act may be cited as the Companies (Amendment) Act, 1993, and shall be read as one with the Companies Act, in this Act referred to as the principal Act.

(2) This Act shall be deemed to have come into operation on the 30th January, 1993.

2. The principal Act is amended by the repeal of the Second Schedule and the substitution therefor of the Second Schedule set out in the Appendix to this Act.
