An Act to amend the Betting Control Act [1st April, 1996

ENACTED by the Parliament of Zambia.

Enactment Short title Cap. 428

- 1. (1) This Act may be cited as the Betting Control (Amendment) Act, 1996, and shall be read as one with the Betting Control Act, in this Act referred to as the principal Act.
 - (2) This Act shall come into operation on the 1st of April, 1996.

Amendment of section 2

- 2. The principal Act is amended in section two—
 - (a) in the definition of " race meeting " by the insertion immediately after the words " persons to watch " of the words", within the country or abroad through television or other media ",; and
 - (b) by the insertion in the appropriate place of the following new definition:
 - " totalizator " means a bookmaker who operates a machine for registering bets at race meetings with a view to divide the total amount (less tax) among those who bet on the winners.
