**An Act to amend the Ministerial and Parliamentary Offices
(Emoluments) Act**

[22nd August, 2005

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Ministerial and Parliamentary Offices (Emoluments) (Amendment) Act, 2005, and shall be read as one with the Ministerial and Parliamentary Offices (Emoluments) Act, in this Act referred to as the principal Act.

(2) Subject to subsection (3), this Act shall be deemed to have come into operation on 1st April, 2005.

(3) Part II of the First Schedule shall come into effect on 1st April, 2006.

2. Section *two* of the principal Act is amended—

(a) in subsection (1) by the deletion of paragraph (c) and the substitution therefor of the following paragraph:

(c) a utility allowance at the annual rate specified for that office in the fourth column of the First Schedule; and

(b) in subsection (2) by the insertion of the words “ and the chief whip ” after the words “ leader of the opposition ”.

3. Section *two A* of the principal Act is amended in subsection (2) by the deletion of the words “ nine hundred and ninety-five thousand two hundred and twelve kwacha ” and the substitution therefor of the words “ ten million kwacha ”

4. The principal Act is amended by the repeal of the First Schedule and the substitution therefor of the First Schedule set out in the Appendix to this Act.

5. For the avoidance of doubt, Part I of the First Schedule shall stand repealed on 1st April, 2006.
