The Patents (Amendment) Regulations, 1981

IN EXERCISE of the powers contained in section *ninety-six* of the Patents Act, the following Regulations are hereby made:

1. These Regulations may be cited as the Patents (Amendment) Regulations, 1981, and shall be read as one with the Patents Regulations (hereinafter referred to as the principal Regulations) and shall apply in respect of business conducted after the publication hereof.
