The Firearms Act (Laws, Volume III, Cap, 111)

### The Firearms (Amendment) Regulations, 1984

IN EXERCISE of the powers contained in section fifty-eight of the Firearms Act, the following Regulations are hereby made:

These Regulations may be cited as the Firearms (Amendment) Regulations, 1984, and shall be read as one with the Firearms Regulations, hereinafter referred to as the principal Regulations.

Title

8.I. No. 256 of 1970

2. Regulation 4 of the principal Regulations is revoked and the following regulation is substituted therefor:

Revocation and replacement of regulation 4

- 4. (1) Application for the issue of a tourist's import Tourist's and/or export permit shall be made to the Registrar in import the Form D in the Second Schedule.
  - export permit
- (2) A tourist's import and/or export permit shall be issued by the Registrar in the Form E in the Second Schedule.
- (3) Every tourist's import permit shall, in addition to such conditions as the Registrar may consider desirable in any particular case, contain the following conditions:
  - (a) no ammunition imported under the authority of the permit shall be used except in connection with a shooting competition or a hunting safari conducted by an approved safari company;
  - (b) the firearms specified in the permit and any unused ammunition imported thereunder shall be removed from the Republic within six calendar months of the date of import;
  - (c) no such firearms or unused ammunition shall be removed from the Republic except under the authority of a tourist's export permit, and unless such export permit is surrendered to a customs officer at the port of exit by the tourist or his agent;

- (d) a tourist's import and/or export permit shall authorise the importation or exportation by the holder of a permit, five firearms none of which shall be of military range;
- (e) a holder of a tourist's import and/or export permit shall not acquire any firearms or ammunition from a safari company or a professional hunter or from any other person without the prior permission of the Commissioner of Police;
- (f) a holder of a tourist's import and/or export permit shall declare the firearm and ammunition to the Registrar, customs officer or any authorised officer at the point of entry or exit in Form E1.

Revocation and replacement of regulation 27

Quantities of ammunition: tourists

- 3. Regulation 27 of the principal Regulations is revoked and the following new regulation is substituted therefor:
  - 27. The quantity of ammunition authorised to be imported, acquired or possessed at any one time by the holder of a tourist's import permit in respect of each firearm specified therein shall not exceed the amounts specified below:

Pistol 10 rounds
Shotgun 100 rounds
Rifle up to 7.66 mm 100 rounds
Rifle above 7.66 mm 100 rounds
Any other 100 rounds

Revocation and replacement of Form D 4. The principal Regulations are amended in the Second Schedule by the revocation of Form D and the substitution therefor of Form D set out in the Appendix hereto.

Insertion of new Form E

5. The principal Regulations are amended in the Second Schedule by the deletion of Form E and the substitution therefor of Form E set out in the Appendix hereto.

Insertion of new Form E) 6. The principal Regulations are amended in the Second Schedule by the insertion of new Form El set out in the Appendix hereto.
