The Income Tax (Foreign Organisations) (Exemption Approval) (No. 9 of 1979) (Amendment) Order, 1986

IN EXERCISE of the powers contained in section *fifteen* of the Income Tax Act, the following Order is hereby made:

1. (1) This Order may be cited as the Income Tax (Foreign Organisations) (Exemption Approval) (No. 9 of 1979) (Amendment) Order, 1986, and shall be read as one with the Income Tax (Foreign Organisations) (Exemption Approval) (No. 9) Order, 1979, hereinafter referred to as the principal Order.

Title and commencement.

(2) This Order shall be deemed to have come into operation on the 14th February, 1985.

2. Paragraph 2 of the principal Order is amended in subparagraph (f) by the deletion of "Mitsubishi International SA." and the substitution therefor of "Mitsubishi Corporation."

3. The Schedule to the principal Order is amended in paragraph 4 by the deletion of the full stop and the addition of the following "which loan agreement has been assigned on the 14th February, 1985, by Mitsubishi International SA to Mitsubishi Corporation."
