The Customs and Excise (Remissions)
(Chikowa Sawmills Limited) Regulations, 1991

IN EXERCISE of the powers contained in section *eighty-nine* of the Customs and Excise Act, the following Regulations are hereby made:

1. These Regulations may be cited as the Customs and Excise (Remissions) (Chikowa Sawmills Limited) Regulations, 1991. Title

2. (1) The Controller shall remit the whole of the duty payable on the goods set out in the Schedule to these Regulations when imported by Chikowa Sawmills Limited up to a value of forty thousand, seven hundred and fifty United States dollars. Remission of duty

(2) The goods on which duty has been remitted under sub-regulation (1) shall not be sold or otherwise disposed of to any person not entitled to import them free from duty, except with the consent of the Controller and upon payment of duty, if any, at the rate leviable at the date of such sale or disposal.
