noticities. The Customs and Excise (General) (Amendment)

In exercise of the powers contained in section one hundred and innety-eight of the Customs and Excise Act, the following Regulations are hereby made:

the Customs and Excise (General) (Amendment) Regulations, 1992, and shall be read as one with the Customs and Excise (General) Regulations, in these Regulations referred to as the principal Regulations.

2. Regulation 75 of the principal Regulations is amended in paragraph (a) of sub-regulation (2) by the deletion of "proof spirits and the substitution therefor of " alcohol by volume ".

3. The principal Regulations are amended by the deletion of regulation 88 and the substitution therefor of the following Regulation:

88. The following fees are prescribed in terms of paragraph (i) of section one hundred and ninety-eight of the Act:

(a) for every licence issued or renewed in terms of section seventeen of the Act, the sum of K1,000 shall be paid;

(b) for every licence issued or renewed in terms section fifty-five of the Act, the sum of K1,500 shall be paid, so, however, that if any licence is issued after the 30th June in any year the sum of K1,000 shall be paid;

(c) for every licence issued or renewed in terms of section ninety-three of the Act, the sum of K1,000 shall be paid;

4. Regulation 89 of the principal Regulations is amended:

(a) by the deletion os sub-regulation (1) and the substitution therefor of the following new sub-regulation:

(1) Subject to the provisions of this Regulation rent on goods placed in a state warehouse shall be charged at the following rates—

(a) for the first week or part thereof, per tonne K100.00

(b) for the second week or part thereof, per tonne K150.00
