The Registration of Business Names Act (Laws, Volume XII, Cap. 687)

The Registration of Business Names (Amendment) Regulations, 1992

In exercise of the powers contained in section eighteen of the Registration of Business Names Act, the following regulations are hereby made:

- 1. These Regulations may be cited as the Registration of Business Names (Amendment) Regulations, 1992, and shall be read as one with the Registration of Business Names Regulations, in these Regulations referred to as the principal Regulations.
- 2. The principal Regulations are amended by the revocation of the Second Schedule and the substitution therefor of the Second Schedule contained in the Appendix hereto.
