**The National Forest No. F. 6: Mwekera (Alteration of
Boundaries) Order, 2015**

IN EXERCISE of the powers contained in section *eight* of the Forests Act, the following Order is made:

1. This Order may be cited as the National Forest No. F. 6: Mwekera (Alteration of Boundaries) Order, 2015. Title
2. The boundaries of National Forest No. F. 6: Mwekera as described in the Schedule to the National Forest No. F6: Mwekera (Declaration of Boundaries) Order, 1946, are altered as described in the Schedule to this Order. Alteration of boundaries

SCHEDULE
(Paragraph 2)

NATIONAL FOREST No. F. 6 MWEKERA

Starting at the International Boundary Pillar BP18, on the Zambia-DR Congo International Boundary, the boundary follows that International Boundary in a general south-easterly direction for a distance of approximately 2,800 metres to its intersection with the western boundary of Mineral Area No. 532M Mwekera to Beacon W418 of that Mineral Area; thence in a straight line southwards along the western boundary of the said Mineral Area on a bearing of 175 degrees for a distance of approximately 3,100 metres to Beacon W419, thence continuing along the western boundary of the said Mineral Area on a bearing of 135 degrees for a distance of approximately 1,400 metres to Beacon W420; thence, in a straight line southwards on a bearing of 178 degrees through a corner beacon of Farm 1838, Mutenge Siding Reserve North crossing the railway line right side of the gravel road from Mufulira-Ndola road for a distance of approximately 2,700 metres; thence in a general westerly direction following the Northern Boundary of the gravel reserve crossing the Mabote Siding road to Beacon MCP1; thence in a Northwesterly direction in a straight line running across the 330KV Power line Reserve on a bearing of 218 degrees for a distance of approximately 2,345 metres to Beacon MCP2; thence north-eastwards in a straight line on a bearing of 34 degrees for a distance of approximately 13,000 metres to Beacon MCP3; thence in an easterly direction in a straight line on a bearing of 90 degrees crossing Nakolwe Stream for a distance of approximately 9,300 metres to International Boundary Pillar BP18, the point of starting.

Included within the above area-defined boundaries but excluded from the Forest Reserve is a portion of the Ndola-Mufulira road strip reserve.

The above described area, in extent 11,539 hectares approximately, is shown bordered green on Plan No. 47/2 deposited in the office of the Survey-General, signed by the Surveyor-General and dated 24th March, 2010.
