 - 3. That upon compliance with the terms of this Consent Judgement the Defendant shall be wholly discharged from any further liability whatsoever and that this action shall be wholly settled and concluded on the terms of this Consent Judgement and shall stand discontinued forthwith.
 - 4. That the Defendant shall bear the costs of and incidental to this action in the agreed sum of ZMW20,000.00 only payable in two equal monthly instalments in the sum of

ZMW10,000.00 each the first such instalment shall be paid on or before the 31st July 2019 an the last instalment on or before 30th August, 2019 respectively.

5. That in default of the Defendant failing to honour its obligations as outlined above, the outstanding sum owed as at the date of default will immediately become payable to the Plaintiffs by the Defendant and such outstanding amount shall be liable to execution.
