**JUDGMENT BY CONSENT PURSUANT TO ORDER 21 RULE 4 OF THE HIGH  
COURT RULES CHAPTER 27 OF THE LAWS OF ZAMBIA**

UPON THE PARTIES agreeing the terms of judgment

AND BY CONSENT through their respective Advocates

IT IS HEREBY ADJUDGED as follows:

1. That Judgement be and is hereby entered against the Defendant in the sum of ZMW138,000.00 (the "Judgement Sum") in full and final settlement and satisfaction of all the Plaintiffs claim herein.
2. That the said Judgement sum of ZMW138,000.00 only shall be paid by the Defendants to the Plaintiff in equal monthly instalments in the sum of ZMW15,000.00 each with the first instalment to be paid on or before 31<sup>st</sup> July, 2019 and the balance thereof on the 30<sup>th</sup> of each consecutive month until the full amount is paid.
3. That upon compliance with the terms of this Consent Judgement the Defendant shall be wholly discharged from any further liability whatsoever and that this action shall be wholly settled and concluded on the terms of this Consent Judgement and shall stand discontinued forthwith.
4. That the Defendant shall bear the costs of and incidental to this action in the agreed sum of ZMW20,000.00 only payable in two equal monthly instalments in the sum of



ZMW10,000.00 each the first such instalment shall be paid on or before the 31<sup>st</sup> July 2019  
an the last instalment on or before 30<sup>th</sup> August, 2019 respectively.

5. That in default of the Defendant failing to honour its obligations as outlined above, the outstanding sum owed as at the date of default will immediately become payable to the Plaintiffs by the Defendant and such outstanding amount shall be liable to execution.
