PETITION

ELECTION FOR Nkoloma Ward **HELD ON THE DAY OF** 12th August, 2021 The Petition of **GODFREY MANCHISHI** whose address for service is House Number 163/6, Misisi Compound in the Lusaka Province of the Republic of Zambia shows that:

- 1. Your petitioner is a person who was a candidate at the aforesaid election;
- 2. And your petitioner states that the election was held on the 12th day of August, 2021 when Davis Chembo, Elijah Kangololo B, Tembo Louis and Godfrey Manchishi were candidates and the returning officer has returned Davis Chembo as being duly elected.
- 3. Your Petitioner says that the 1st Respondent was not duly elected as the 1st Respondent and his agents committed the following illegal acts –
- 4. Your Petitioner avers that the election was held on the 12th day of August, 2021 when Davis Chembo, Elijah Kangololo B, Tembo Louis and Godfrey Manchishi were candidates and the returning officer has returned Davis Chembo as being duly elected.

- 5. I and my campaign team were not given a platform to campaign freely. My campaign team and I were beaten each time we tried to wear regalia and comply with the campaign time table.
- 6. Mr. Simfukwe, a youth leader was attacked at Misisi Campaign Centre (pa ma tiles) together with subordinates. The said centre was demolished and the subordinates were beaten and wounded.
- 7. Homes for women were demolished and they were raped by the 1st Respondent's PF members and campaign team and this was reported to the Police Station.
- 8. The 1st Respondent and his agents who were the perpetrators of violence instilled fear in lives of the people including the registered voters under the Ward to the extent that people left Nkoloma Ward 1 for fear of being killed.
- 9. During campaign period Mr. Andrew Zulu was with the knowledge and consent of the 1st Respondent abducted by PF members wearing PF regalia. He was beaten and they were in process of cutting off his head when Tasila Lungu happened to be passing by and they then rushed to attend to her.
- 10. Ntambo Meleki, who was part of the 1st Respondent's campaign team in Nkoloma Ward bought beer for voters on the queue. They would enter his tavern and join queue.
- 11. When voting was going on, the Presiding Officer transferred Polling Agents from one Polling Station to another. At 15:00 hours, George Simukali was transferred from Zambezi C Polling Station to Ufulu Polling Station.
- 12. At Totalling Centre at Chawama School, the Petitioner was with Tyson Mphande, Gabriel Mwale (Ward 3) and Bright Mafuta (Ward 4) the ECZ said it did not have Gen 20 originals and copies on which to base results for councillors. Hence consolidation of the results was made on assumption basis.
- 13. Your Petitioner avers that there were serious variances between the register of voters, the record of proceedings and the Gen 20 forms.
- 14. Polling agents were compelled to sign on Gen 20 when voting was still going on.

- 15. the Record of Proceedings showed that there were no registered voters for Chitimba 1 Polling Station yet there are 862 registered voters for Chitimba 1 Polling Station
- 16. And your petitioner prays that –
- (a) A declaration that the illegal practices committed by the 1st Respondent and his agents materially affected the election result.
- (b) The nomination or election of the 1st respondent be declared void; or
- (c) The petitioner be declared duly nominated or elected.
- (d) An Order that the costs of the Petition be borne by the Respondents.
