Notice of Interconnection Rates Determination for Fixed and Mobile Electronic Communication Networks

PART I

PRELIMINARY PROVISION

1. (1) This notice may be cited as the Zambia Information and Communications Technology Authority (Interconnection Rates Determination No. 3 of 2016).

This notice shall come into operation on 1st January, 2016 and remain effective until 31st December, 2017.

(2) In this notice unless the context otherwise requires, Authority means the Zambia Information and Communications Technology Authority established by the ICT Act No. 15 of 2009

(3) This notice specifies the Interconnection Rates for fixed and mobile electronic communication networks and shall be binding on all licensed fixed and mobile service providers operating in the Republic of Zambia. Further this notice of determination supersedes all agreements and provisions in relation to interconnection (call termination) rates in existing and current Interconnection Agreements between mobile and or fixed electronic communication networks.

PART II

CONFIRMITY WITH THE LAW

2. All determination in this notice are based on findings from an update of the Cost Models for electronic communication services exercise that was conducted by PricewaterhouseCoopers LLP of the United Kingdom on behalf of the Authority. This notice of determination also takes into consideration tariff regulation provisions under Sections 41 (5), 47 (2), 48 (3) and 50 of the ICT Act.

PART III

INTERCONNECTION RATES

3. (1) The interconnection rates specified in the Schedule to this notice shall be charged among licensed electronic communication network operators in the Republic of Zambia.

(2) The Authority may review and vary interconnection rates at any time where circumstances require.

4. Interconnection rates shall, be charged in Zambian Kwacha as prescribed by the glide path in the schedule to this notice.

5. (1) Interconnection rates shall be used for termination of traffic between network service operators licensed in Zambia.

(2) For the avoidance of doubt, international incoming traffic that transits through an international gateway within the Republic of Zambia and terminates on another national network shall fall under the ambit of this determination.
