Anthrax Outbreak, Chama District

IN ACCORDANCE with the provisions of Section 12, 22 and 23 of the Animal Health Act of 2012 of the Laws of Zambia, it is notified for the information of the public in general and the hunting/farming community in particular that there is an outbreak of Anthrax in Chama District of Muchinga Province. In view of this occurrence, the under listed measures will apply in the District with immediate effect until further notice:

1. Hunting (Safari, resident or local) of wild animals within Chikwa hunting block of Musalango Game Management Area of Muchinga Province is suspended until further notice.
2. No wildlife products like skins, meat, trophies will be allowed into or outside Chikwa hunting block of Musalango Game Management Area of Muchinga Province until further notice.
3. No fishing will be allowed within Chikwa hunting block of Musalango Game Management Area of Muchinga Province until further notice.
4. No dead animal should be touched or consumed but reported to the nearest veterinary office.

To this effect, the Ministry of Fisheries and Livestock has instituted control measures and hunter/farmers and members of the public are requested to cooperate as these measures are being implemented.

Any person or persons found contravening the measures directly or indirectly will be prosecuted and any wildlife products involved will be destroyed without compensation.
