Sale of Designated Commodities During the 2018/19 Agricultural Marketing Season

PURSUANT to the provisions of Section 8(2) of the Food Reserve Act, Cap. 225 of the Laws of Zambia, the Food Reserve Agency hereby announces its intention to sell part of the designated commodities in the National Strategic Food Reserve during the 2018/19 Agricultural Marketing Season.

The Agency intends to sell maize, soya beans and paddy rice on the local market between November, 2018 and October, 2019 through allocations to various purchase categories and may use different procedures for different areas.

The maize, soya beans and paddy rice are located at various depots spread across the country and will be sold on ex-depot or free on board (FOB) basis.

The sale is in order to meet relief and household food security needs, create space, properly handle, rotate, distribute and position designated commodities to various parts of the country as part of the national strategic food reserve. The commodity sell program will be done immediately the necessary authority from the line Ministry has been obtained to sell stocks from the national strategic food reserve. HAVING read the summons and Affidavits and annexures thereto, and UPON hearing Counsel for the Applicant,

IT IS HEREBY ORDERED THAT:

1. A Restraining Order is granted made in terms of Section 27 of the Forfeiture of Proceeds of Crime Act No. 19 of the Laws of Zambia restraining the property cited above and particularly described in the Schedule attached hereto and seized from the Respondents by members of the Zambia Police Service on the 29th March, 2017 in the Mbala District of the Northern Province in the Republic of Zambia.

2. The property shall remain in the possession of the Attorney General of the Republic of Zambia until the expiration of this Order in terms of Section 28 (1) (b) of the Forfeiture of Proceeds of Crime Act No. 19 of the Laws of Zambia or until the conclusion of the forfeiture proceedings to be instituted by the Applicant in respect of the property under Section 31 of the Forfeiture of Proceeds of Crime Act or until the matter is otherwise concluded.

3. In terms of Section 28 of the Forfeiture of Proceeds of Crime Act, all persons with knowledge of this Order are, other than as required and permitted by this Order, prohibited from removing, taking possession of or control over, dissipating, interfering with, diminishing the value of, pledging or otherwise hypothecating, attaching, or dealing in any other manner with the property to which this order relates.

4. The Applicant shall cause a copy of this order to be published in one issue of the Government Gazette as soon as is reasonably practicable after obtaining the Order.

5. The Applicant shall in terms of Section 30 (*a*) of the Forfeiture of Proceeds of Crime Act cause notice of this Order, together with documents supporting the application, to be served on the Respondents and any other person who becomes known to the Applicant to have an interest in this matter.

6. Any person who has an interest in the property and who intends opposing the application for an order forfeiting the property to the State or applying for an order excluding his or her interest from a forfeiture order in respect of the property, may enter an appearance giving notice of his or her intention in terms of Section.30 (*b*) of the Forfeiture of Proceeds of Crime Act.
