**Notice for Forbearance**

THE Authority is mandated under Section 47 of the Information and Communication Technologies (ICT) Amendment ACT of 2010 to regulate tariffs (prices) for electronic communication products and services. Section 47 (2) of the ICT Amendment ACT of 2010 prescribes that tariffs for electronic communication services should be "transparent, non-discriminatory and based on costs not greater than the cost of providing the service." In the context of tariff regulation, the main aim of this provision of the Act has been to avoid excessive pricing by ensuring that tariffs are cost based and providers of electronic communication services apply reasonable margins in their pricing. In the execution of its mandate to regulate tariffs for electronic communications products and services, the Authority takes into consideration the 3 main objectives of tariff regulation which are summarised below:

- Financing objectives – which aim to ensure that regulated operators are permitted to earn sufficient revenue to finance on-going operations and future investments;
- Efficiency objectives – which aim to promote efficiency in the supply of telecommunications services in terms of allocative, productive and dynamic efficiencies; and
- Equity objectives – which are concerned with the fair distribution of welfare benefits among members of society.

It is clear that Section 47(2) of the ICT Amendment Act is best applied on specific unit costs for standalone services. This was particularly appropriate for legacy networks that had uniquely identifiable network elements and resources dedicated to each service. However, given the convergence of technology onto a single IP platform, it is almost impractical to apply the principles of cost based tariff regulation contained in section 47 of the ICT Amendment Act particularly in instances where the marginal variable cost of a unit of service may be negligible despite having significant fixed costs arising from the maintenance of a converged IP network.

In an attempt to ensure that the objectives of tariff regulation highlighted above are preserved under a converged technology regime, the Authority intends to respond to among other issues the state of heightened competition in the ICT Sector, advancements in technology and the substantial investments in network capacity by the mobile network operators. The Authority has also noted the improvements in business intelligence solutions that facilitate new and dynamic billing/revenue models such as telescopic billing and bundling of different products into one subscription package.

Given the current shift in service delivery in the ICT sector from stand-alone services, each with their own unit cost and price point, to bundled or combo offers that contain voice, SMS and data at a single combined subscription price, it has become impractical to apply cost based pricing principles on a standalone unit of service basis. It has been observed that through variable and dynamic billing, an operator is able to stimulate usage by discounting services or charging below cost at certain times or for certain services and still meet the financing objective through other services during peak hours. It has further been noted that discounted offers are not restricted to the aforementioned stand-alone services but also applied to bundled offers.

The said discount offers are sometimes equal to or below the cost of providing a standalone service particularly in the case of on-network voice service. This is due to the fact that on-network traffic does not attract an interconnection charge as the case is with off-network communication. Therefore an operator may be able to manage intra network costs and offer the service at a discounted or below cost price while generating revenue from other services. Further, most operators have indicated that they have excess capacity on their networks that could leverage on a technical efficiency objective as well as allocative efficiency strategy to monetize the idle capacity. This is further supported by the argument that the operators meet fixed costs related to this excess capacity.

The above notwithstanding, the Authority is mandated to ensure that all inter-network communications are cost based in view of the statutory obligation with regards to settlement of traffic termination costs in instances where communication takes place across networks.

For this reason, the majority of significantly discounted offerings are restricted to on-network communication.

Therefore, in the absence of an interconnection charge for voice and SMS services within a network, it is possible for MNOs to earn a return even if the service is offered below cost particularly in instances where network utilization is low.

In view of the foregoing, the Authority intends to forbear section 47(2) of the ICT Amendment Act of 2010 in relation to voice and SMS on-net tariffs for an initial period of six(6) months for below the line subscribers, i.e. subscribers that spend less than K10 per month on a given network. This entails that MNOs will be at liberty to charge below cost for the above services and customer segment.

It is anticipated that this forbearance will:

- Allow for more innovative and dynamic revenue models to be explored and developed;
- Enable MNOs to increase market share and network utilisation by providing significantly discounted on-network communication; and
- Allow operators to earn revenue even during low utilisation periods by incentivising below the line users to become revenue generating users.

The Authority will however continue to monitor the operations of the providers of electronic communication services to ensure that they remain viable and deliver the highest value for the services consumers demand.

In view of the foregoing, this notice seeks submissions from interested parties and all relevant stakeholders in relation to the proposed forbearance of section 47 (2) of the ICT Amendment Act.
