(1) The Controller shall remit the whole duty payable on the goods set out in the Schedule hereto when imported by Lake Hotels Limited up to a value of approximately one million, two hundred and fifty thousand, six hundred and eighty-nine kwacha.</p> <p>(2) The goods on which duty has been remitted under sub-regulation (1) shall not be sold or otherwise disposed of to any person not entitled to import them free of duty, except with the consent of the Controller and upon payment of duty, if any, at the rate leviable at the date of such sale or disposal.</p> | <p>Remission
