IN EXERCISE of the powers contained in sections eighteen and twenty-eight of the Tolls Act, 1983, the following Regulations are hereby made:

1. These Regulations may be cited as the Tolls (Entry Fees) (Exemption) Regulations, 1988.

Title

2. The vehicles whose description appears in the Schedule herete shall be exempt from the payment of the entry fees referred to in subsection (1) of section eighteen of the Act when entering Zambia at Nakonde and carrying bags of maize and beans from the Government of Kenya to the Government of the Republic of Zambia.
