STATUTORY INSTRUMENT NO. 5 OF 1989

The Roads and Road Traffic Act  
(Laws, Volume XV, Cap. 766)

The Roads and Road Traffic (Re-Classification of Roads  
and Appointment of Highway Authority) Notice, 1989

WHEREAS in accordance with the provisions of section *twenty* of the Roads and Road Traffic Act, notice was given of the intention that Rural Road Serial No. RD45 and part of Rural Road Serial No. RD44 were to be re-classified District Roads.

AND WHEREAS that notice was published in the Gazette No. 3228 dated 22nd January, 1988, as Gazette Notice No. 96 of 1988.

AND WHEREAS the other requirements of section *twenty* of the Roads and Road Traffic Act have been complied with.

NOW THEREFORE, in exercise of the powers contained in sections *five*, *seven* and *nineteen* of the Roads and Road Traffic Act, the following Notice is hereby made:
