The Forests Act (Laws, Volume 12, Cap. 199)

The National Forest No. F 42, Mufulira (Alteration of Boundaries) Order, 2007

IN EXERCISE of the powers contained in Section *seventeen* of the Forests Act, the following Order is hereby made:

- 1. This Order may be cited as the Local Forest No. F 42, Title Mufulira (Alteration of Boundaries) Order, 2007.
- 2. The Boundaries of Local Forest No. F 42, Mufulira, shall be altered by the deletion of existing boundary description thereof and the substitution therefor of the description set out in the Schedule to this Order.

Alteration of boundaries

3. Statutory Instrument No. 54 of 1970 is hereby amended accordingly.

Amendment of S.I. No. 54 of 1970

SCHEDULE (Paragraph 2)

NATIONAL FOREST No. F 42, MUFULIRA

Starting at beacon W391, the most westerly corner beacon of Lot 592/M, the boundary proceeds in the South-easterly direction in a Straight line on a bearing of 116 degrees for a distance of approximately 3,550 metres to beacon W410; thence in south easterly direction in a straight line on a bearing of 109 degrees for a distance of approximately 2,400 metres to beacon CK361; thence south eastwards in a straight line on a bearing of 180 degrees for a distance of approximately 1,450 metres to beacon CK362; thence South-westwards in a straight line on a bearing of 232 degrees through beacon HT1089 for a distance of approximately 2,150 metres to beacon HT1088; thence South-eastwards in a straight line on a bearing of 127 degrees through beacon HT1094 for a distance of approximately 1,150 metres to a point on the right bank of Mutundu river; thence down the Mutundu river on the right bank to its Confluence with Kasaria stream; thence north westwards in a straight line through beacon MFR on a

bearing of 304 degrees for a distance of approximately 1,450 metres to a point on the left bank of Kalindiri river; thence down the left bank of this river for a distance of approximately 4,300 metres to its confluence with unnamed river; thence up the left bank of this unnamed river for a distance of approximately 3.050 metres to its confluence with unnamed tributary; thence up the left bank of this tributary for a distance of approximately 1,375 metres; thence northwards in a straight line on a bearing of 360 degrees for a distance of approximately 900 metres to a point east of Kilometer peg 14 on the Zambia Railways Strip Reserve; thence Westwards in a straight line on a bearing of 270 degrees for a distance of approximately 3,300 metres to beacon CK360; thence on the eastern edge of the Railway Strip Reserve for a distance of approximately 1,950 metres to beacon OU 416; thenceNorth-eastwards in a straight line on a bearing of 75 degrees for a distance of approximately 1,600 metres to beacon SK1; thence north westwards in a straight line on a bearing of 348 degrees for a distance of approximately 575 metres to beacon SK2; thence northeasterly direction in a straight line on a bearing of 327 degrees for a distance of approximately 825 metres to beacon SK3; thence South-easterly direction in a bearing of 117 degrees for a distance of approximately 1,700 metres to beacon J372; thence north-easterly direction along the Southern boundaryof Farm 1381 on a bearing of 64 degrees for a distance of approximately 200 metres to beacon J371; thence North-easterly direction in a straight line on a bearing of 34 degrees for a distance of approximately 2,050 metres to beacon W391, the point of staring.

The above described area in extent 5,233 Hectares approximately is shown bordered green on Plan No. FR2/7 deposited in the office of the Surveyor-General signed by him and dated 19th June, 2006.
