The Customs and Excise (Remission) (Electronic Communications) Regulations, 2011

IN EXERCISE of the powers contained in section *eighty-nine* of the Customs and Excise Act, the following Regulations are hereby made:

| <p>1. These Regulations may be cited as the Customs and Excise (Remission) (Electronic Communications) Regulations, 2011.</p> | Title |
| <p>2. (1) Subject to the other provisions of these Regulations, a remission of the whole of duty payable shall be granted in respect of the equipment, capital goods and other materials set out in the Schedule imported or taken out of bond by persons engaged in the construction of electronic communication transmission towers in unserved and underserved areas:</p> <p style="padding-left: 40px;">Provided that all such equipment, machinery and other materials are to be built into, or to form a part of, an electronic communications transmission tower.</p> <p>(2) The goods on which duty has been remitted under subregulation (1) shall not be sold or otherwise disposed of to any person not entitled to import them free of duty except with the consent of the Commissioner-General and upon payment of duty, if any, at the rate leviable at the date of such sale or disposal.</p> | Remission of duty |
| <p>3. The importer of the goods referred to in regulation 2 shall furnish the Commissioner-General details of—</p> <p style="padding-left: 40px;">(a) the activities to be carried out and the location of the towers; and</p> <p style="padding-left: 40px;">(b) the nature, quantity, substantive tariff description and classification in the customs tariff and customs value of the goods in respect of which the remission is sought.</p> | Description of goods |
