**The Customs and Excise (Provisional Safeguard Measures) Order, 2015**

IN EXERCISE of the powers contained in section *eighty B* of the Customs and Excise Act, the following Order is made:

(1) This Order may be cited as the Customs and Excise (Provisional Safeguard Measures) Order, 2015.</p> <p>(2) This Order shall remain in operation for one hundred and eighty days from the date of its publication in the <i>Gazette</i>.</p>   | <p>Title,<br/>commence-<br/>ment and<br/>duration</p>                      |
| <p>2. In this Order, unless the context otherwise requires—<br/>“COMESA” means the Common Market for Eastern and Southern Africa;<br/>“protected goods” means goods in respect of which provisional safeguard measures are imposed; and<br/>“SADC” means the Southern African Development Community.</p>  | <p>Interpretation</p>  |
| <p>3. (1) The importation into Zambia of the goods listed in the Schedule is subject to customs duty of 15% when imported from COMESA and SADC member States implementing the free trade area and 25% when imported from any other State or territory.</p> <p>(2) Notwithstanding subparagraph (1), goods with HS Code 7210 imported from any other State or territory shall be subjected to customs duty of 30%.</p> | <p>Provision of<br/>safeguard<br/>measures for<br/>protected<br/>goods</p> |

7209	Flat-rolled products of iron or non-alloy steel, of a width of 600 mm or more, cold-rolled (cold-reduced), not clad, plated or coated. -In coils, not further worked than cold-rolled (cold-reduced)
7209.16.00	--Of a thickness exceeding 1 mm but less than 3 mm
7209.17.00	--Of a thickness of 0.5 mm or more but not exceeding 1 mm
7209.28.00	-Not in coils, not further worked than cold-rolled (cold-reduced) --Of a thickness of less than 0.5 mm
7210	Flat-rolled products of iron or non-alloy steel, of a width of 600 mm or more, clad, plated or coated. -Plated or coated with tin:
7210.11.00	--of a thickness of 0.5 mm or more
7210.20.00	-Plated or coated with lead, including terne-plate
7210.30.00	-electrolytically plated or coated with zinc -otherwise plated or coated with zinc:
7210.41.00	--Corrugated -plated or coated with aluminium
7210.61.00	--Plated or coated with aluminium-zinc alloys
7210.69.00	--Other
7210.70.00	-Painted, varnished or coated with plastics
