| Inspection of Provisional register of voters | 4. The inspection of the provisional register of voters shall commence on Sunday 15th May, 2016 and close on Saturday 21st May, 2016 at all polling stations, countrywide. |
| Certification of the Register of voters | 5. The register of voters for the 2016 general elections shall be certified by the 2016 the Director of Elections on Sunday, 31st July, 2016. |
| Nomination Dates | 6. Nominations for the Presidential election shall be lodged with the Returning Officer from Monday, 30th May, 2016 to Friday 3rd June, 2016 between 0900 hours and 1500 hours, at Mulungushi International Conference Centre, Lusaka. The processing of one hundred supporters of Presidential candidates shall be conducted by Assistant Returning Officers in all provincial capitals from Monday, 23rd May, 2016 to Friday 27th May, 2016 between 0900 hours and 1500 hours. |
| | 7. Nominations for Members of Parliament in all the constituencies shall be lodged with the Returning Officers on Tuesday 31st May, 2016 between 0900 hours and 1500 hours at the gazetted nomination centres. |
| | 8. Nominations for Mayors and Council Chairpersons in all the districts shall be lodged with the Returning Officers on Monday, 30th May, 2016 between 0900 hours and 1500 hours at the gazetted nominated centres. |
| | 9. Nominations for Councilors in all the wards in the districts shall be lodged with the Returning Officers on Tuesday, 31st May 2016 between 0900 hours and 1500 hours at the gazetted nomination centres. |
