Introduction:

Zambia has in the last six to ten years experienced economic growth in the region of 6 percent. Since economic growth is related to energy requirement the electricity sector has also experienced growth ranging from 150MW to 200MW annually. However due to climate change factors the generation from the hydro power plant have been adversely affected resulting in an energy deficit.

In view of this, Demand Side Management (DSM) measures can be used to mitigate the energy deficit through energy efficiency and conservation. Consequently ZESCO intends to harness the abundant solar energy resource to take off some loads from the grid supply through the implementation of the design, supply and installation of Solar Geysers and Solar Photo Voltaic (PV) panels as DSM solution.

Background:

The demand for electric power in Zambia, especially in the urban cities of Lusaka, Ndola, Kitwe and Livingstone has been on the increase. Mining, Industrial, Agricultural, Commercial and Domestic electricity consumption has been on the increase at a very fast rate. The changing weather pattern has also resulted in poor rain rainfall and inadequate water in our dams, thereby adversely affecting power generation. The rapid growth has in turn triggered the need to invest in new power generation, transmission, distribution and supply infrastructure necessary to deliver electric power to load centers in order to provide a more reliable, affordable, quality and safe service to the customers.

Objectives:

To mitigate the situation ZESCO has decided to implement Demand Side Load Management. In this respect ZESCO wishes to invest in the following Demand Side Management (DSM) initiatives:

- (i) Solar Geysers; and
- (ii) Distribute Solar PVs to power existing electric geysers and control other selected loads.

Scope of Assignment:

Phase I of the project will cover 50,000 units; and
