The Public Service Pensions Fund Board (PSPFB) is a creation of the Public Service Pensions Act, CAP 260 of the Laws of Zambia, mandated to control and administers the Fund in accordance with sound business practices. The Board is also mandated to invest Members' funds in order to enhance the financial health of the institution.

The Public Service Pension Fund Board (PSPFB) has about 10 hectares of land divided into sixty two (62 No.) plots on title in the Humphrey Mulemba Villa Park of Solwezi district in the Northwestern Province of Zambia where it intends to construct Sixty Two (62) modern Houses.

PSPFB seeks to contribute in mitigating the current housing deficit in the Country by constructing housing units to Solwezi. It intends to achieve this objective by implementing access to quality and affordable housing to the community in the Humphrey Mulemba Villa Park. If implemented systematically, the project is capable of addressing part of the housing challenge in Solwezi, add value to the metro of Solwezi, trigger an increase in the levels of employment, and help to diversify the PSPF portfolio. This Project will not only address part of the housing deficit in Solwezi but also generate an additional income stream for pension obligations that the Board faces.

The PSPFB now invites eligible qualified Zambia registered Consulting Firms to express interest in providing consulting services related to the design and costing of the proposed construction of three bedroomed houses in Solwezi.

**OBJECTIVE**

The main objective of the assignment is to carry out detailed design of the proposed Housing Estate and to cost all related elements incidental or coincidental to the delivery of a Housing Estate with amenities to the satisfaction of the Board.
