The tender is open to Zambian Contractors who are registered with the National Council for Construction for 2016 in Category B Grades 3 and 4. Bidders should also submit valid certificates of practice for the year 2016 from the Engineering Institution of Zambia as well as the Engineering Registration Board.

Bidders are free to submit bids for one or more lots. However, award of contract will be restricted to amaximum of two lots per bidder. Furthermore, in the event that all the bidders who reach commercial evaluation have already been awarde the maximum lots the evaluation committee will consider awarding more lots to already awarded bidders as long as they demonstrate their capacity to effectively handle the projects simultaneously.
