## Securities and Exchange Commission

## Public Notice

THE Securities and Exchange Commission (hereinafter referred to as “the Commission”) is a statutory body established under the Securities Act, Cap. 354 of the Laws of Zambia (repealed) and whose existence is continued under the Securities Act, No. 41 of 2016 (hereinafter referred to as “the Securities Act”). The Commission has a statutory mandate to protect investors in the capital markets.

Section 4(2) of the Securities Act empowers the Commission to exempt persons or securities from the requirements of the Act. In exercise of the powers vested in the Commission pursuant to section 4(2) of the Securities Act, the Commission hereby notifies the public that:

1. The Board of Directors of a listed company or company whose securities are registered with the Commission are temporarily EXEMPTED from reporting on the effectiveness of the company’s internal control system in its annual report as required by section 147 (2) of the Securities Act;
2. Auditors of listed companies or companies whose securities are registered with the Commission are temporarily EXEMPTED from issuing a statement, in the audit report of the company, as to the existence, adequacy and effectiveness or otherwise of the internal control system of the company as required by section 149 of the Securities Act.
3. The temporary exemptions for both the Board of Directors and the Auditors will cease to operate for all annual reports covering financial reporting periods beginning on or after 1st January 2019;
4. The exemption is made in order to allow the Commission and the Zambia Institute of Chartered Accountants (ZICA) develop and implement an appropriate reporting framework to guide the form and content of compliance with the requirements of sections 147 and 149 of the Securities Act; and
5. This exemption does not preclude Auditors from the requirement to audit the annual financial statements of listed companies or companies whose securities are registered with the Commission as provided under section 148 (2) of the Securities Act.
