The Zambia Information And Communications Technology Authority (ZICTA)

For the Determination of Relevant Products Markets and the Existence of Dominant Position Amongst Licensed Operators in the Electronic Communications Industry

In accordance with Section 40 of the Information and Communication Technologies Act, No.15 of 2009

THIS Notice confirms the determination by ZICTA that certain holders of licences ("licensees") issued by ZICTA are holding a dominant position in the indicated relevant electronic communications markets.

This determination is madein accordance with -

- (a) competition procedure for determining the relevant product market in the electronic communications industry in Zambia;
- (b) share of supply threshold for establishing existence of dominant position as set out in the Competition Guidelines of 2010 issued by ZICTA pursuant to the Information and Communication Technology Act; and
- (c) Section 15 of the Competition and Consumer Protection Act of 2010.

ZICTA hereby gives Notice of the determination of the following licensees as holding a dominant position in the indicated relevant markets in the electronic communications industry specified against its name below:

The above determination is based on the competition assessment of the Zambian ICT sector based on the ICT indices that ZICTA collected from licensed operators covering a period between 01stJanuary2017and 30th September2017. The circumstances and analysis supporting the determination of dominance in the relevant markets are based on international best practices of assessing competition levels in markets.

Further note that this determination is valid from 01st January 2018 to 31st December 2018.

All terms and expressions defined in the Information and Communication TechnologiesAct, the Competition and Consumer Protection Act and the Competition Guidelines shall have the same meaning when used herein as they do in the respective legislation and guidelines.
