The Public Service Pensions Fund Board (PSPFB) is a creation under an Act of Parliament No. 35 of 1996 Cap. 260 of the Laws of Zambia. It administers a defined benefit scheme (PAYGO system) and provides, under the rules of the Fund, retirement benefits for the Defence Forces, Security, Civil Service, Police and Prisons Service, Teaching Service and Judicial Service. It is a tax exempt approved scheme under the Income Tax Act. Employees' contribute at the rate of 7.25% of their basic salaries and the employer the same rate. The functions of the Board are:

- (a) Control and administer the Fund in accordance with sound business practices and in the best interest of the members of the Fund, subject to the provisions of the Act;
- (b) Establish a scheme for homeownership by the members of the Fund and to grant, on such terms and conditions as the Board shall determine, loans to members of the Fund for the purpose of building or purchasing their own residential property; and
