**Notice to Exempt the Bank of Zambia from Compliance with Section and Dealers in Government Securities from Compliance with Section 77(1) of the Securities Act No. 41 of 2016 Respectively**

TAKE NOTICE THAT pursuant to section 4 (2) of the Securities Act No. 41 of 2016 (Hereinafter referred to as "the Securities Act") the Securities and Exchange Commission (hereinafter referred to as "the Commission") hereby exempts the Bank of Zambia solely from complying with Section 20 of the Securities Act which requires a person operating a securities market and a clearing and settlement agency to apply for a licence to operate the securities market or central securities depository.

Further, the commission hereby exempts any dealer who transacts in government securities at or through the Central Securities Depository System and Electronic Trading platform operated by the Bank of Zambia solely from the application of Section 77 (1) of the Securities Act that prohibits the transaction of securities on a securities market not operated by a securities exchange.

Notwithstanding paragraph (2) of this Notice, any dealer that transacts in any securities other than government securities at or through the Central Securities Depository System and Electronic Trading Platform operated by the Bank of Zambia shall not be exempt from the application of section 77(1) of the Securities Act.

The exemption granted to a dealer under paragraph 2 shall not relieve the dealer or any person who transacts in securities on the said Electronic Trading Platform or Central Securities Depository System from complying with other requirements under the Securities Act and the rules made thereunder.

Transactions in government securities done at or through the Bank of Zambia Electronic Trading Platform or Central Securities Depository System shall be reported, on or immediately before close of business, to a securities exchange, pursuant to section 79 of the Securities Act No. 41 of 2016. The Bank of Zambia shall also furnish a copy of the said report to the Commission before close of business.
