IN EXERCISE OF POWERS contained in sections ten, eleven, twelve, thirteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three of the Value Added Tax Act, the following Rules are hereby made:

The Gazette Notice No. 633 of 2018

1. (1) These Rules may be cited as the Value Added Tax (General) (Amendment)(No.) Rules, 2018 and shall be read as one with the Value Added Tax (General) Rules, 2018 in these Rules referred to as the principal Rules.

Amendment of the third Schedule

(2) These Rules shall come into operation on 1st October 2018 and shall cease to have effect on 31st December 2018.
