IN EXERCISE of the powers contained in Section Ten, Eleven, Twelve, Thirteen, Eighteen, Twenty seven, Fifty two and Fifty three of the Value Added Tax Act, Chapter 331 of the Laws of Zambia (hereinafter referred to as "the Act") the following rules are hereby made:

CASH BASIS OF ACCOUNTING FOR TAX

Title and Commencement

1. These Rules may be cited as the Value Added Tax General(Amendment) Rules, 2018.

Interpretation

2. In these Rules— *Gazette Notice No. 925 of 2016* Sub Rule 7 (1) (c) is added:

(c) or a VAT registered supplier, who is in the electricity generation subsector, may account for tax on supplies effected and deduct input tax on the basis of payments received and made for supplies.
