Alleviation of Quarantine Restriction Following the Control of the Foot and Mouth Disease Outbreak in Eastern Province

IN ACCORDANCE with the provisions of Section 25 of the Animal Health Act No. 27 of 2010 of the Laws of Zambia, it is hereby notified for the information of the farming community in particular and the general public that following the control of the foot and mouth disease outbreak in Chipata, Lundazi and Vibwi Districts in Eastern Province, the Department of Veterinary Services has with immediate effect reduced the quarantine restrictions that were imposed.

The following measures shall now apply:

1. The inter-district movement of live cattle, goats, sheep, pigs and their products are now allowed except for Lundazi District where Lusuntha, Mwase and Egichikeni Veterinary Camps remain under quarantine;
2. Live goats, sheep and beef meat and products are allowed to move out of the Province;
3. All such movements will only be allowed after inspections and issuance of stock movement permits by the respective District and Province Veterinary authorities in accordance with the Animal Health Act No. 27 of 2010; and
4. Live cattle, pigs and pig products are still not allowed to move out of the Province.
