The Public Service Pension Fund Board (PSPF) is a funded defined benefits pension scheme which provides pension benefits to retired public servants and survivors. The Fund is also responsible for secure and profitable investment of pension funds in financial markets. Its membership comprises the Teaching Service, Police and Prisons Service, Defence Forces, Civil Service, Judiciary Service and Zambia Security and Intelligent Services. The Board is mandated by Act No. 35, Cap 260 of the Laws of Zambia, to undertake the valuation of the fund at intervals not exceeding 3 years.

In compliance with the Act, the Board seeks to engage the services of an actuary to carry out an assessment of the Fund as at 31st December 2020.

**BACKGROUND**

The fund has a total of 149,240 members, pensioners and beneficiaries representing 93,454 serving members and 55,786 pensioners and beneficiaries respectively.

The pensionable age according to Act has been revised to 60 years for all employees with options of early retirement and late retirement of 55 years and 65 years respectively. The membership contribution from the employer and employee stands at 7.25% each.

The last two actuarial valuations were conducted in 2014 and 2017.

The Board's Strategic Plan (2020-2024) focuses on three corporate objectives as highlighted below:

- (a) To provide quality service to members, retirees, pensioners and beneficiaries
- (b) To enhance financial health and sustainability of the Fund
- (c) To consolidate good and fair employee relations that support enhanced Fund productivity.

The actuarial report is thus critical in assisting the Board in the achievement of the above stated objectives as it repositions itself going forward. The Board therefore places value and importance to this exercise which is aimed at appreciating the current financial position of the Fund and proposes ways of sustaining the Fund for the benefit of members, pensioners and beneficiaries.
