## **The Value Added Tax Act** (Laws, Volume 19, Cap. 331)

### **The Value Added Tax (General) (Amendment) (No. ) Rules, 2021**

IN EXERCISE of powers contained in sections ten, eleven, twelve, thirteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three of the Value Added Tax Act, the following Rules are hereby made:

*Title, Gazette Notice No.310 of 2020*

1. (1) These Rules may be cited as the Value Added Tax (General) (Amendment)(No.) Rules, 2021 and shall be read as one with the Value Added Tax (General) Rules, 2020 in these Rules referred to as the principal Rules.

#### *Amendment of Third Schedule*

2. The Third Schedule to the principal Rules is amended by the addition of the items listed in the Table set out in the Appendix to these Rules.

#### **Appendix** (Rule 21)

HS Code	Description
8421.39.00	Other Filtering or purifying machinery and apparatus for gases
8405.10.00	Producer gas or water gas generators, with or without their purifiers; acetylene gas generators, and similar water process gas generators, with or without their purifiers

Commercial	K0.015 or 15 Ngwee
Others	K0.015 or 15 Ngwee
