BACKGROUND

The last two actuarial valuations were conducted in 2017 and 2020. As at the end of the last actuarial valuation, the scheme has explored ways to reform the scheme so that it remains sustainable. Some changes made include retirement age and governance changes done through amendment of the Act and Statutory Instruments.

The five corporate objectives in line with the Fund's Strategic Plan (2020 - 2024) include the following:

- (a) To improve the quality of service to enhance membership experience.
