Animal Health Act (Act No. 27 of 2010)

Declaration of the 2023 Anthrax Outbreak as an Emergency

IT IS HEREBY NOTIFIED for the information of the general public, the farming community and livestock purveyors that for the purpose of control, the 2023 anthrax outbreak has been declared an Emergency pursuant to Section 63 (C) of the Animal Health Act. In view of this, it is hereby ordered that the under listed control measures be in force to control the outbreak. These measures will be subject to review after vaccination of the target animals in the affected districts of Eastern, Southern and Western Provinces.

- 1. Animals, animal products and animal by-products:
 - (a) The movement of live animals, animal products and animal by-products, into, within and out of the outbreak areas of Southern and Western Provinces, and Lumezi District of Eastern Province is suspended with immediate effect to facilitate for vaccination and decontamination.
 - (b) The movement of live animals, animal products and animal by-products including wildlife into, within and out of the low-risk and high-risk areas of Eastern, Southern and Western Provinces, may be allowed from feedlots, bulking centers and farms enclosed with a fence, subject to approval from the Department of Veterinary Services.
 - (c) Where animals including their products and by-products are allowed to move (as provided for in clause (b)), they shall be accompanied by a Stock Movement Permit issued by the Department of Veterinary Services. These animals including their products and by-products, shall move under the escort of an officer from the Department of Veterinary Services.
 - (d) All cattle, sheep, goats and donkeys in the outbreak areas of Eastern, Southern, and Western Provinces shall undergo mandatory vaccinations.
 - (e) All carcasses of animals dying from anthrax or suspected anthrax should not be opened, consumed by humans or fed to animals, but must be reported to the nearest District Veterinary Office and disposed of under the supervision of qualified personnel.
 - (f) Anthrax carcass graves including any land or areas contaminated or suspected to be contaminated with the disease-causing agents (anthrax bacteria or spores) in the outbreak areas shall be mapped and undergo appropriate decontamination by qualified personnel.
 - (g) Premises where live animals, animal products or animal by-products are sold, processed, displayed or exhibited, stored, imported or exported or distributed including transport vessels and general equipment used at such premises may undergo screening for anthrax as may be determined by the authorities.
 - (h) Premises screened as provided for in clause (g) and found to be positive for anthrax, shall be subjected to disinfection and other such measures as deemed necessary.
 - (i) Animal carcasses, meat or meat products from low-risk and high-risk areas may only be allowed into outbreak areas under strict supervision of the Department of Veterinary Services.

- (j) Live animals, animal carcasses, meat or meat products from low-risk or high-risk areas transiting through the outbreak areas shall do so under strict supervision of the Department of Veterinary Services and the One-Health collaborating institutions.
- (k) Sellers and transporters of meat and meat products shall be in possession of a copy of a meat inspection certificate or document, issued by officers under the Department of Veterinary Services or the Ministry of Health (Environmental Health Technologists) or Ministry of Local Government and Rural Development (Health Inspectors), certifying such products to be fit for human consumption.
- *(l)* Milk producers must implement heightened biosecurity measures at production sites
- (m) Milk processors buying milk from Milk Collection Centers in low-risk and high-risk areas must show proof that the milk has been adequately pasteurized and processed, in accordance with approved procedures of the Department of Veterinary Services or the Ministry of Health (Environmental Health Technologists) or Ministry of Local Government and Rural Development (Health Inspectors). This is so as to mitigate the risk posed by environmental contamination or any other contamination of the milk.
- 2. Wildlife Species
 - (a) Heightened surveillance and decontamination may be conducted in outbreak areas, low-risk and high-risk areas hosting wildlife.
 - (b) Wildlife hunting activities and movement of wildlife species shall not be allowed where surveillance in 2(a) reveals presence of anthrax.
 - (c) Wildlife hunting activities and movement of wildlife species may be allowed in low-risk and high-risk areas provided surveillance in 2(a) reveals no presence of anthrax.
- 3. General Provisions
 - (a) The Director of Veterinary Services shall take any other such measures deemed necessary for the purposes of controlling the anthrax disease and ensuring public health and safety.
 - (b) The measures in this Notice shall not apply to poultry and fish.
 - (c) Any person found contravening the measures outlined in this Notice shall be prosecuted and appropriate penalties applied as provided for in the Animal Health Act No. 27 of 2010.

Definitions in this Notice

Low-Risk areas: include all areas that are free from the anthrax disease and are not designated as outbreak areas

High-Risk areas: These are areas which have previously reported outbreaks or are adjacent to affected districts

Outbreak areas include: Sinazongwe, Kalomo and Kazungula districts (Southern Province); Nalolo, Senanga, Mongu, Sioma, and Sesheke Districts (Western Province); and Lumezi District (Eastern Province)

Qualified Personnel includes: officer in the one health sectors such as veterinary officer, medical officer, public health officer from the local authorities or the ministry of health, officer under the department of national parks
